

Visitor Regulations of the Moravian Brethren Museum

2. Opening Hours and Admission Fees

- The museum is open according to the published opening hours.
- By prior arrangement, visits outside standard opening hours are possible.
- Christmas opening hours are set individually and published each year.
- Admission fees are determined by the valid price list displayed at the ticket office and published on the website of the market town Suchdol nad Odrou www.suchdol-nad-odrou.cz and at www.moravian.cz.
- Admission fees can only be paid in cash in Czech crowns.
- **Children under 6, holders of disability passes (ZTP), and AMG members have free entry.**
- The museum reserves the right to change opening hours and admission fees.

3. Behaviour in the Exhibition Areas

- Smoking and any handling of open fire are strictly prohibited inside the museum.
- Visitors are required to behave considerately towards other visitors and the exhibited items.
- Touching the exhibits is prohibited unless expressly stated otherwise (e.g., for interactive elements).
- Photography is allowed only **without flash**. The use of tripods, selfie sticks, and other devices is permitted only with staff approval.
- Video recording is only allowed with prior consent from museum management.
- Mobile phones must be muted; phone calls are not permitted in the exhibition area.
- Loud behaviour, running, noisy games, and other disruptive activities are not allowed.
- Food and drinks are not permitted in the exhibition areas.
- Sitting on the floor or leaning against display cases or exhibits is prohibited for safety reasons.
- Prams, scooters, bicycles, and similar means of transport are not allowed in any part of the museum.
- Lost and found items must be reported to museum staff without delay.
- In case of fire or any other emergency, visitors must follow the instructions of authorised personnel.
- In the event of visitor injury, the staff member on duty will provide first aid or arrange medical assistance.
- Visitors must not damage or misuse fire protection equipment or fire safety devices.
- During group visits of pupils or students, responsibility for the group lies with the accompanying teacher.
- Visitors may record their comments, observations, or experiences from the tour in the visitor book located in the exhibition area.
- The museum does not provide storage for valuables or luggage unless stated otherwise.
- The museum is not responsible for items left unattended.

4. Rules for Persons with Specific Needs

- The exhibition is partially barrier-free.
- Assistance persons are permitted to accompany visitors.
- Assistance dogs are allowed entry.

5. Safety and Property Protection

- Children under 10 may only visit the museum when accompanied by an adult.
- Entry with animals is not permitted, with the exception of assistance dogs.
- It is forbidden to bring weapons, pyrotechnics, alcohol, narcotic and psychotropic substances, or other dangerous items into the museum.
- Visitors are liable for any damage they intentionally or negligently cause to equipment or exhibits.
- Any injury or damage must be reported to staff immediately.

6. Group Visits

- Groups of more than 10 people must book in advance.
- If the number of visitors is high, groups may be divided according to the museum's capacity.

7. Final Provisions

- Visitors are obliged to follow the instructions of museum staff.
- Visitors who violate the visitor regulations may be asked to leave the museum without the right to a refund of the admission fee.

These Visitor Regulations are effective from 1 January 2026.
